II LCEF Shared Blessings Report-Bruce Hahn

- ➤ Bruce Hahn provided an update on the Lutheran Church Extension Fund (LCEF) Shared Blessings rebate program.
- Trinity qualified for a maximum rebate of over \$61,000 for exceeding our goal of member investment accounts. The minimum is 35% of eligible members with Trinity having 412 investors which is 38.3% of communicant members.
- ➤ LCEF invests in Lutheran Churches and there are still opportunities to support LCEF, Trinity and other Lutheran congregations
 - Young Investors-under 18 can invest for \$25
 - Other opportunities for adult investors starting for as little as \$25 per month
